CAPABLE OF HOUSING 22 FAMILIES AT A TIME, DAKOTA WOODLANDS SHELTERED A TOTAL OF 68 FAMILIES IN 2022. ALTHOUGH THE AVERAGE LENGTH OF STAY IN 2022 WAS 160 DAYS, FAMILIES CAN STAY IN THE SHELTER AS LONG AS NECESSARY TO SUCCESSFULLY TRANSITION FROM HOMELESSNESS TO HOMES OF THEIR OWN. WHEN THEY ARRIVE, OUR STAFF WORK WITH EACH FAMILY TO IDENTIFY BARRIERS AND CREATE A PLAN TO OVERCOME CHALLENGES TO GAIN STABILITY. 75% OF FAMILIES EVENTUALLY MOVE INTO SAFE, AFFORDABLE HOUSING.
