SEVENTY PERCENT OF ALL INDIVIDUALS IDENTIFIED AS BIPOC; 47% REPORTED A HISTORY OF DOMESTIC VIOLENCE; 57% HAVE ANNUAL INCOMES OF \$12,000 OR LESS; AND 30% REPORT HAVING A MENTAL OR PHYSICAL DISABILITY. THE AVERAGE LENGTH OF STAY FOR FAMILIES IN 2024 WAS 136 DAYS. 166 INDIVIDUAL'S MOVED INTO PERMANENT HOUSING.
