When they arrive, our support staff helps each family create an individual plan focusing on the areas of responsible renting, parenting, finance, budgeting and developing other skills needed to help ensure their eventual success in the community. 83% of residents eventually move into safe, affordable housing. Once they move, Dakota Woodlands follows up with each family for up to two years with assistance to ensure they continue to do well in the community.
